## Competition Entry Details - October 9 to 12, 2024, Montreal

### ENTRY PERIOD

**FROM MAY 1<sup>ST</sup> TO SEPTEMBER 1<sup>ST</sup>, 2024**

### SINGLE ENTRY FEE PER PRODUCT

**\$269.00 CAD, INCLUDING CANADIAN TAXES**

Canadian federal and provincial taxes (14.975%) are included in the amount of the above fee. Federal law requires all participants to pay these taxes, given that the competition is being held on Canadian soil.

### SIGN UP IN FOUR EASY STEPS

#### 1 - CREATE AN ACCOUNT ON THE WEBSITE

If this is your first time entering a wine, you must create an account on our website at [www.selectionsmondiales.ca](http://www.selectionsmondiales.ca).

#### 2 - ENTER YOUR WINE

To enter the competition, click on "REGISTRATION" on the SMV home page and then select the applicable wine category. Click on the "Add a Wine" button to proceed. You will be prompted for further information. Once you have completed the required fields, click on "Add a Wine." Each wine you add can be found in your shopping cart. Repeat the process for each wine you wish to enter.

#### 3 - ARRANGE FOR YOUR SAMPLES TO BE SHIPPED

You can make shipping arrangements and pay the corresponding fees directly in your shopping cart. In partnership with Eurofret, we will pick up your samples at your door (for a very competitive price, as part of a deal exclusive to SMV Canada) and deliver them to our warehouse in Montreal, where they will be checked and prepared for the event.

#### 4 - PAY THE CUSTOMS CLEARANCE FEES

Every producer taking part in the competition will be required to pay customs clearance fees. To proceed, simply add the fees to your cart to pay them online. Note that only one customs clearance per producer is necessary, no matter how many products you are entering in the competition. We strongly recommend that you include this item in your entry form and pay the required fees right away to avoid subsequent delays. If your shipment gets to the Canadian border and you have not pre-paid the clearance fees, your samples will be held by customs officials until the situation is rectified.

**EXCEPTION: Note that producers whose wines are already in Canada are not required to pay customs clearance fees. This applies to Canadian wine producers as well as producers from other countries whose products have already been brought into the country through a private importer or a Canadian agent.**

#### 5 - PROCESS YOUR PAYMENT

Please submit your payment online at [www.selectionsmondiales.ca](http://www.selectionsmondiales.ca) after completing your entry form. Our Stripe-based processing system accepts all credit and debit cards. Make sure the information you have provided is complete and accurate BEFORE clicking on "Pay." ## SHIPPING/RECEIVING OF SAMPLES AT OUR WAREHOUSE IN MONTREAL

FOR CANADIAN PRODUCERS AND INTERNATIONAL PRODUCERS WHO HAVE A PROMOTIONAL AGENT IN CANADA

If you choose to send your samples via an alternate carrier, please follow the instructions below. (Be sure to compare prices against the deal available exclusively to SMV Canada entrants before you decide.)

**IMPORTANT! In Canada, it is illegal to send alcoholic beverages by mail. Any such products shipped in this manner will be confiscated and destroyed by Canada Post.**

If you opt for a courier service such as FedEx, DHL or UPS, the terms of shipment must be indicated as "DAP Quebec – Customs Clearance Not Included." Customs clearance services in Canada will be provided by Eurofret. Please note that producers must pay a \$70.00 CAD brokerage fee (taxes included).

**SAMPLES MUST BE PACKED SECURELY IN CRATES AND CLEARLY MARKED "Sélections Mondiales des Vins 2024." Each shipment must include the following:**

- A printout of the completed online entry form
- A pro forma invoice showing the following:
  - Full address for the producer
  - Full address for Sélections Mondiales des Vins
  - Product name
  - Colour of wine
  - Alcohol content (%)
  - Bottle format (750 ml or 1 litre)
  - Number of samples per product (2)
  - Ex-cellar, net and commission-free price
  - Total value in CAD, USD or EUR
  - Currency in CAD, USD or EUR
  - Country of origin
  - Phrase "Competition Samples – Value for Customs Purposes Only"
  - **IMPORTANT:** Pro forma invoices bearing a unit price of 1 CAD, 1 USD or 1 EUR will not be accepted
